ANNUAL CONGREGATIONAL MEETING MINUTES

Date of TUC Annual Congregational Meeting: February 24, 2013

1. **CALL TO ORDER:** Reverend Bruce Kearley called the Annual Congregational Meeting to order at 12:05 pm on February 24th, 2013, welcoming all who were in attendance. Seventeen (17) parishioners were in attendance.
2. **OPENING DEVOTIONS:** Rev. Bruce Kearley opened the meeting with the prayer "A prayer for the Reign of Christ" from Voices United, followed with a scripture reading from Ecclesiastes #39 and ended with a short story entitled "The Lesson of the Cracked Water Pot".
3. **CHAIR AND SECRETARY FOR 2013 CONGREGATIONAL MEETING:** Rev. Kearley called for nominations for the Chair and Secretary for the meeting. Mr. Robert Jenkins nominated Gillian Corbett for Chair, who graciously declined. Lloyd Hobbs nominated Robert Jenkins for Chair, who accepted. Robert Jenkins nominated Jim Rowsell for Secretary, who accepted. In each case, Rev. Bruce called three times for nominations and hearing none, declared nominations cease, after which he declared Robert and Jim elected to fill the posts and called them to the desk.
4. **ACKNOWLEDGEMENT AND THANKS:** Robert Jenkins, on behalf of the entire congregation, expressed our heartfelt thanks to Rev. Bruce for his Ministry and his tireless hours of hard work over the past year, and noted that we are truly blessed to have him here at Topsail United. He also thanked Gillian Corbett, the outgoing Chair of the Official Board, for all her work and that of the entire Board in 2012. Regrets were received from Valerie Howe, Steven Rogers, Eileen Green, Nadine Hollett and Pat Jones.
5. **APPROVAL OF AGENDA:** The agenda was unanimously approved. The Chair suggested that the 2012 Reports of Committees be presented and discussed, with the exception of the Finance Committee, and there then would be one motion to accept them all. The financial reports, including the 2013 Budget would be approved in separate motions. All in attendance agreed.
6. **CHURCH ROLLS:** It was noted that names of individuals were once again included in Baptisms, Marriages and Funerals, and it was pointed out that one new member by transfer had been spelled incorrectly – Vera Penney should have read Verna Penney.
7. **REMEMBRANCE OF THOSE PASSED IN 2012:** Rev. Bruce read the names of those who had passed away in 2012, followed with a moment of silence and the prayer 'What a Friend We Have in Jesus' for them and their families, as well as for other members of our church family who had also lost loved ones.

8. **MINUTES OF 2012 ANNUAL CONGREGATIONAL MEETING:** There being no errors or omission, it was **MOVED by Freeman Budgell/Boyde Clarke that the Minutes of the 2012 Annual Congregational Meeting be adopted as presented. CARRIED.**
9. **2012 ANNUAL REPORTS:**
- 9.1 **Minister:** Rev. Bruce brought attention to his letter, highlighting: the wonderfully successful 175th Anniversary Celebrations, the wonderful variety in Worship that we enjoy at Topsail, the challenges we all must face in our daily devotions, the interest and high involvement of our Youth, the good work of our CD Minister, Steven Rogers, the fact that the 46 Baptisms this year brings his career total to approximately 600 children. He commented that this year would see his retirement from the Canadian Armed Forces as Chaplain. He thanked the congregation for freely sharing their gifts and talents and thanked the Church staff and the outgoing and incoming Board members for all their help. He ended his remarks by reading from a newspaper article that had been written about the 175th Anniversary. There were no questions, however, Wanda Saunders, thanked Rev. Bruce for his personal caring in such a large congregation.
- 9.2 **Chair of the Board:** Gillian Corbett, outgoing Chair of the Board, submitted her report. There were no questions.
- 9.3 **CD Minister:** Steven Rogers was absent due to illness, however, Robert Jenkins acknowledged Steven's active participation and vision which has resulted in successful programs and increased participation of our youth. Rosalind Foley commented that she has found working with Steven a wonderful experience.
- 9.4 **Membership and Pastoral Care:** Gillian Corbett expressed her thanks to Valerie Howe, whose work has resulted in more than 140 being placed on our email lists, thereby enabling the Church to better communicate with everyone.
- 9.5 **Worship and Sacraments:** Rosalind Foley had nothing to add to the report. The Chair commented that we are truly blessed to have Lorraine and Harry in our congregation, able to fill in for services on short notice.
- 9.6 **Organist/Choir Director:** Allan Parsons brought a question as to the training we have been providing to Nadine this past year. Lloyd explained that some training was provided in 2012 as part of her contract, and that while some of that training needs to be completed in 2013, there has been no decision on further training at this time.
- 9.7 **Senior Choir:** No questions.
- 9.8 **Christian Development:** During the year, Jan Negrijn stepped down and Sharon Deemer was appointed as the new Chair. Gillian Corbett commented that the committee is currently reorganizing.
- 9.9 **Sunday School:** Gillian Corbett commented that the Sunday School has seen the addition of many new members over the past year. Freeman Budgell commented that while the Sunday School is not primarily Steven Roger's responsibility, he has done quite a bit of work reorganizing it.

- 9.10 Children and Youth Music Program:** Gillian Corbett commented that there is an ongoing challenge to find meeting times that are acceptable to all young persons. Rosalind Foley commented that it seems that with so much going on in their lives, it seems organized activities no longer hold a high priority in our youth's daily lives. She added that her choir had 17 members last year, and she thoroughly enjoys working with them.
- 9.11 Ministry and Personnel:** Lloyd thanked all the Church Staff for their help in 2012, with special thanks to Rev. Bruce and Lynn Mercer.
- 9.12 Outreach:** No questions. Rev. Bruce commented that the local food bank is finding operations much harder since they were forced to move locations to a place where the rent is approximately three times what it had been.
- 9.13 Property and Trustee:** Installing new roof shingles had been a major expense last year and some fundraising is planned. Work on redoing the downstairs bathrooms is in the planning stages.
- 9.14 Men's Club** No questions.
- 9.15 United Church Women:** It was mentioned that a conflicting practice for the World Day of Prayer Service resulted in many members not being able to attend the Congregational Meeting today. No questions on the report.
- 9.16 Harvest Festival:** Gillian Corbett pointed out that this church function involves participation from all committees and groups within the Church.
- 9.17 175th Celebrations:** The Chair commented that these celebrations had been a complete success.
- 9.18 Long Term Planning:** No questions/comments.

10. ADOPTION OF REPORTS:

MOTION: It was Moved by Freeman Budgell/Mitch Moran that the Reports 9.1 to 9.18 be accepted as submitted. CARRIED.

11. FINANCE COMMITTEE

Boyde Clarke reviewed the report, highlighting the fact that Topsail United has the highest percentage of families on PAR of any church in Newfoundland and Labrador, and has resulted in the Church not having to borrow to get through the summer months, as it has had to do in previous years. He also noted the incorrect spelling of his name on page 37.

The Chair questioned whether the fundraiser for the roof repairs should be more 'visible' and 'pushed' to be more successful. Allen Parsons questioned the need for fundraisers at all if we have this much money in the bank. Boyde responded that notwithstanding our current finances, if we do not continue to be vigilant and responsible, we could easily find ourselves back in a poor financial situation.

Bob Bennett asked where the large bequest from last year would be used, suggesting that it be earmarked for the rehabilitation of the downstairs, which could possibly cost in the vicinity of \$110,000.00 - the Church borrowing the balance. He further suggested that a memorial plaque recognize its use. Freeman Budgell and Bob Jenkins both commented that due to the fact that there were no set conditions attached to the bequest, they felt that the decision as to the disposition of the bequest rests with the decision of the Official Board.

MOTION: It was MOVED by Boyde Clarke/Lloyd Hobbs that the Finance Committee report be accepted as presented. CARRIED.

12. BUDGET FOR 2013

Boyde Clarke then reviewed the Budget for 2013, noting that Steven Roger's hours had been increased from 20 to 30 hours per week resulting in an increase in budget for Ministry and Personnel Operating expenses. Allan Parsons expressed his concern over the amount spent for printing the Annual Report. Gillian responded that the difference between printing it ourselves and getting it printed at Blackwood Printing was very little and we receive a much better product. It was **MOVED by Boyde Clarke/Lloyd Hobbs that the 2013 Budget be accepted as presented. CARRIED.**

13. NOMINATING COMMITTEE REPORT

The report of the nominating committee was brought forward. The Chair called three times for any other nominations to the Official Board. Max Robbins and Allan Parson were both nominated, but declined. Lloyd nominated Wanda Saunders, who accepted. It was **then MOVED by Gillian Corbett/Max Robbins that the slate of members submitted, with the addition of Wanda Saunders, be accepted as the Official Board for 2013. CARRIED.**

14. ADJOURNMENT AND BENEDICTION

The Chair thanked all for coming to the meeting. It **was MOVED by Freeman Budgell/Mitch Moran that the meeting be adjourned. CARRIED.** Rev. Bruce gave the Benediction.

Dear Friends,

Greetings in Christ's name. 2013 was a very busy year at Topsail United (*The Church by the Side of the Road*). As I was preparing to write this annual letter my thoughts began to focus on the many ways we think of God and how God leads us each day. Truly God has led us though 2013 in worship and church activity and in our commitment to witness and celebrate God's presence with us. The image of a helping hand is one that attests to God's leading. The beautiful hymn; "*Jesus' Hands Were Kind Hands*" (#570 in Voices United) reflects the gentle presence of Jesus with us as we strive to become the helping hands of Jesus to those around us. The first verse of this beautiful hymn acknowledges the blessings of Jesus on our lives and the second verse asks us to share those blessings with those around us as we witness to our faith each day.

***Jesus' hands were kind hands, doing good to all,
Healing pain and sickness, blessing children small,

The verse at the beginning of this letter demonstrates it is God's hand that leads us daily. CONGREGATIONAL DESIGNATED MINISTER REPORT

Greetings!

As I reflect on the many challenges and blessings of 2013, I am reminded of the words written by the hymnist R. Deane Postlethwaite:

The care the eagle gives her young, safe in her lofty nest, is like the tender love of God for us made manifest. As when the time to venture comes, she stirs them out to flight, so we are pressed to boldly try to strive for daring height. (Voices United #269)

At Topsail United Church, we are blessed with many talented and dedicated individuals who strive for daring heights through their service and ministry. Our Sunday School leaders volunteer much time and energy as they continue to improve and expand our curriculum. I was pleased to lead our Sunday School teachers in a number of Godly Play training sessions in the Summer of 2013. We continue to learn and grow together as we deliver an exciting program for children and young families.

Over the past year, our congregation has benefited greatly from the involvement of our youth. During the “Sacred Bodies” event, we explored various body images as portrayed in popular media and compared these with body images found in the Bible whilst discussing the theology of a healthy body image. This event was a joint gathering with our confirmation class and much camaraderie was enjoyed amongst the participants. In the Fall, youth met regularly to rehearse choreography for a dance that was later performed under black light during the Christmas Eve service. They played an important role throughout the year in reading scripture, leading worship services, distributing bulletins, setting up sound equipment, controlling the sound mixer, and assisting in the leadership of Sunday School cooking classes. The leadership of our youth was clearly evident during the very successful fundraising concert in May and in the ‘Messy Church’ year-end celebration in June.

The Children’s Choir and Youth Band provided beautiful music to our Family Services that were held on the 3rd Sunday of each month. The Rhythm Band continued to grow to total of 10 members and their music adds great energy to our worship whenever they perform. We were fortunate to have both laity and clergy participate in a special Lenten study entitled “Word for Lent”. Using video, scripture, and the image of a stained glass window, the study group explored a different theme for each week of lent. In the autumn season, we enjoyed three special presentations led by study group members: Religious Fundamentalism & Politics; Christian Mysticism; and The Social Gospel: Rev. Oliver Jackson & The Great Depression.

I would like to thank Rev. Bruce for his support and encouragement throughout the year. I also say thank you to the staff, committee members, board members, and congregation members for all the work and contributions you’ve made this past year.

Welcome to all who have found a church home at “The Church by the Side of the Road” over the past year and thank you all who continue to support our church community.

Historic Roll: The Historic Roll contains the names of all those who have joined Topsail United by confirming their baptismal vows, by profession of their faith, or by the transferring in of their membership. The Roll should only contain the names of those members who **reside in the area and who continue to have an active interest in the life and work of the church.** Membership is subject to review by the Official Board. In 2013, **5** new members were added by Confirmation, **2** new members were added by transfer and **4** members were removed by their death. The Historic Roll currently lists **504** members. Please call the Church Office if you need information about transferring your Membership or wish to confirm your baptismal vows.

Church Records: Church records for 2013 list **36 Baptisms, 14 Marriages and 22 Funerals** conducted at Topsail United Church throughout the year.

Sunday School: Invitations to attend Sunday School were sent to 27 children living in the Pastoral Charge who were baptized at Topsail United Church and started kindergarten in September 2013.

Confirmation: Invitations to attend Confirmation Classes were sent out (for the first time) **to those who turned 12 in 2013.**

Supporting Families List: In 2013 there were 300 families financially supporting the church with annual donations of over \$50.00 and a further **150** families under our Pastoral Care.

Newsletter: All those on the Supporting Families list receive the Spring and Fall Newsletter 171 Newsletters are delivered by email; 100 Newsletters are mailed; and 160 Newsletters are hand delivered by 22 faithful “Neighbourhood Contacts”.

“Meet and Greet”: The Committee continues to sponsor “Meet and Greet” each Sunday following worship (except for Family Worship, which is sponsored by Outreach). This social gathering provides the chance to meet new people and have a chat.

Pastoral Care Team: Discussion is ongoing on the viability of training volunteers for visiting seniors who can no longer get out to church, but would appreciate such a visit in addition to their visit from Rev. Bruce.

OUTREACH COMMITTEE FOOD BANK REPORT

Thank you for your support of the CBS/Paradise Community Food Bank through donations of both food and money during 2013. Please remember the first Sunday of each month is highlighted for donating to the Food Bank but you may bring items at any time. Thank you to the Men's Club for their additional donations of food throughout the year.

The Food Bank continues to be well supported by the community at large and again there was a tremendous response to the Christmas Hamper program. Our congregation donated monies in excess of the requested 40 Hampers. A total of 254 Christmas Hampers were prepared. Some of our regular clients are looked after by other organizations such as "Single Parents" for their Christmas Hamper. All Christmas Hamper as well as regular hamper requests are filed with "Food Sharing" to eliminate duplications.

The majority of monthly hampers are requested by people who are in receipt of government assistance. We know that there are others in need, especially the working poor and those waiting to receive benefits. If you know of someone who is in need please let them know that the Food Bank is there for them. No one is turned away. The Food Bank has been seeing a steady increase again in regular clients during 2013.

The Food Bank continues to supply lunch items, on request, to schools in the CBS/Paradise area - to be given out as needed.

The move from the premises in Chamberlains to Manuels (behind "Mary Brown's") continues to put added pressure on the finances. The Food Bank Board has appealed for financial help from businesses in both communities and continues to seek increased financial help from the member Churches. Fundraisers are being held and we ask for your support whenever possible.

The Annual General Meeting of the Food Bank is held each May and is open to the general public.

2013 was a very active year for the Property/Trustee Committee with the following projects representing just some of the issues dealt with by Committee members during the year:


- Shingle repair following damage from a severe windstorm.

I would like to thank all Committee members for their continued support and dedication to the time consuming process of maintaining our church buildings and cemeteries during the past 12 months and, in particular, I would like to recognize the efforts of Bob Bennett for his role in coordinating several of the more significant projects listed above.
